As you are aware, the United States Bankruptcy Court for the Middle District of Florida previously confirmed AmeriNet’s Chapter 11 plan of liquidation. Pursuant to AmeriNet’s Chapter 11 plan, the AmeriNet, LLC Creditors Trust (the “Trust”) was created and Larry S. Hyman was appointed as the Liquidating Trustee for the Trust.

In accordance with the Chapter 11 plan, the Trustee has liquidated all of AmeriNet’s assets that are capable of being liquidated and, as a result, the Trustee has cash available to make a final distribution to holders of allowed claims against AmeriNet’s estate.
